IT NATION EVOLVE GUEST NON-DISCLOSURE AGREEMENT (“AGREEMENT”)

Thank you for your interest in IT Nation Evolve Peer Groups. Transparency in sharing information and confidentiality make IT Nation Evolve and peer interaction work. Release. You release and agree to hold harmless ConnectWise and any of its officers, directors, shareholders, employees, contractors and/or any individual or entity affiliated with ConnectWise from all actions, claims, or demands (including attorney’s fees and expenses) that you, your heirs, beneficiaries, representatives, successors and assigns now have or may hereafter have for injury, damage, or death resulting from your participation in IT Nation Evolve related activities.

You understand that in the event of a violation of any provision of this Agreement, ConnectWise shall have the full right to seek injunctive relief, in addition to any other rights provided in this Agreement or by operation of law, without the requirement of posting bond. You shall reimburse ConnectWise for all costs, expenses or damages that it incurs as a result of any violation of any provision of this Agreement. This obligation shall include court costs, litigation expenses, and reasonable attorneys’ fees. This Agreement will be governed by the laws of the State of Florida. You consent to the jurisdiction and venue of any state or federal court in Hillsborough County, Florida.
